## NOTICE OF SELECTION FOR ADMISSION TO THE MASTER'S DEGREE OF THE POSTGRADUATE PROGRAM IN AGROECOLOGY AND RURAL DEVELOPMENT - CLASS 2025

The Coordinator of the Graduate Program in Agroecology and Rural Development (PPGADR-Ar) announces that applications are open and establishes the rules for admission of applicants to the MASTER'S DEGREE PROGRAM IN AGROECOLOGY AND RURAL DEVELOPMENT offered at the Center for Agrarian Sciences, Federal University of São Carlos (UFSCar) – Araras campus, SP, with classes starting in March 2025.

#### 1. SELECTION PROCESS

This selection process offers **27** (**twenty-seven**) **places** in the Master's program in Agroecology and Rural Development. Places will be filled in descending order of the final scores achieved by the applicants until all places have been filled in each Line of Research. The highest scoring applicants will be eligible for enrollment. The total number of places per Line of Research is determined in **item 9 of this Notice.** 

- 1.1 Only applicants whose score is equal to or greater than six (6) in PHASE 1 (Evaluation of the Research Project) and PHASE 2 (Defense of the research project) of this Notice, will pass.
- 1.2 There will be Affirmative Actions aimed at two social groups, as described in item 2 of this Notice.
- 1.3 Even if not all places are filled, no other selection processes will be carried out.

#### 2. AFFIRMATIVE ACTION POLICY

The Affirmative Action Policy adopted by the Graduate Program in Agroecology and Rural Development is designed to promoting ethnic-racial and class equity in the admission of its students. A 50% reservation of places in the selection process is defined for students in two (self-declared) ethnic-racial quota options: black (black and brown) and indigenous, based on two types of action.

- 2.1 **Quotas of 11 (eleven) places**, of the total number of places, for self-declared black applicants (black or brown, according to the declaration of the Brazilian Institute of Geography and Statistics (IBGE); 5 (four) of these places for the line of research Technology and Processes in Agroecological Systems and 6 (four) of these places for the line of research Agroecology, Rural Development and Society. Allocation of places to self-reported black applicants will depend on whether they individually meet the requirements of the phases of this selection process. Places under the quota system (11 places) that were unfilled will be offered to the other applicants.
- 2.2 **Quotas of 2 (two) places**, of the total number of places for self-reported indigenous applicants: 1 (one) place for the line of research Technology and Processes in Agroecological Systems and 1 (one) place for the line of research Agroecology, Rural Development and Society. Allocation of places to self-reported indigenous applicants will depend on whether they individually meet the requirements of the phases of this selection

process. Places under the quota system (02 places) that were unfilled will be offered to the other applicants. The number of quotas in this Notice was determined based on the percentage of people of indigenous descent (0.8%), as surveyed by the IBGE Census in 2022.

- a) applicants willing to participate in the selection process under the Affirmative Action Policy, must fill in the Request for Application to the Selection Process (ANNEX 1) and check one of the options: Affirmative Actions self-reported black applicant (black or brown) or self-reported indigenous applicant, and fill out and sign the self-report on Color/Race, self-reported black applicant (ANNEX II) or statement on ethnic belonging, indigenous applicant (ANNEX III).
- B) applicants **NOT** willing to participate in the selection process under the Affirmative Action Policy, must fill in the Request for Application to the Selection Process (ANNEX 1) and check the option **GENERAL APPLICANT.**
- 2.3 For high school graduates from government-funded schools or private schools (on a full scholarship, with 100% of the monthly fees covered), a bonus point of 0.5 (five tenths) shall be added to their final scores to determine the final qualifying list. To be eligible to receive a bonus point on their final scores, applicants must:
- A) have fully completed their secondary education in a government-funded school, or completed all or part of their secondary education in a private school on a full scholarship (100% of monthly tuition fees) throughout the entire study period.
- b) fill in in the Request for Application to the Selection Process (ANNEX I) the item *addition of bonus point* with the name of the school, municipality, state and country where they attended high school.
- c) send digital copies of supporting documents as a single PDF file, named as Affirmative Action Bonus Score; proof that they attended high school in a government-funded school, or that they have attended all or part of their secondary education in a private school on a full scholarship (100% of monthly tuition fees) throughout the study period, together with the other documents required for the selection process.

#### 3. SELECTION PROCESS

The Selection Process will be carried out in three phases: Phase 1 - Research Project Evaluation (eliminatory and ranking round), Phase 2 - Defense of the Research Project (eliminatory and ranking round) and Phase 3 - Curriculum Evaluation (ranking round), pursuant to item 6 of this Notice.

- 3.1 Brazilians and foreigners, holders of higher education diplomas in any area of knowledge, can apply for admission to the Master's Program in Agroecology and Rural Development at PPGADR-Ar.
- 3.2 Applicants to the Master's program will have their request for application analyzed by the Preliminary Committee for the Selection Process, especially appointed by the Graduate Council (CPG) of PPGADR-Ar for this particular purpose. The members of the Committee are

listed in item 7 of this Notice, for the purpose of checking the documentation required for application.

- 3.3 Applicants who have submitted incomplete documentation, or sent it in files whose format/extension is other than the one required in this notice (namely, PDF), will have their application rejected. They will not be allowed to send additional documents after the deadline for application is over.
- 3.4. The procedures and deadlines for filing appeals and challenging requests are indicated in item 11 of this notice.
- 3.5. PPGADR-Ar is linked to the Interdisciplinary Area of the Coordination for the Improvement of Higher Education Personnel (CAPES) and has two Lines of Research, indicated in item 4 of this notice. - 3.6. The timetable of the Selection Process is stated in Annex VI of this Notice.
- 3.7. The checklist of documents that must be sent for application to the Selection Process is provided in Annex VII of this Notice.

#### 4. Lines of Research

The two Lines of Research at PPGADR-Ar are:

#### 4.1. Technologies and Processes in Agroecological Systems:

Assessment and indicators of the sustainability of agroecosystems; technological processes aimed at family and/or organic agriculture; impact assessment and environmental and forest management in agroecosystems; use of plants and microorganisms for sustainable agricultural production; crop physiology and food quality; post-harvest technologies and processes; small-scale food processing.

#### 4.2. Agroecology, Rural Development and Society:

Evaluation of forms of social organization and public policies that directly or indirectly relate to Agroecology and Sustainable Rural Development; innovations in systems of processing, distribution and sale of agricultural products; cultural and educational aspects of the greening of agriculture and the rural environment; national and international political debates on family agriculture and peasantry.

- b) to be entitled to the addition of a bonus point to the final score of the selection process, Affirmative Action Policy, send digital copies of the document(s) in a single PDF file named as affirmative action bonus point, as specified in item 2.3 of this Notice.
- c) applicants who chose to join the selection process through the Affirmative Action Policy Ethnic-racial quota, shall **fill in, sign and send the self-report for color/race for self-reported black applicant (black or brown) (ANNEX II) or statement on ethnic belonging to indigenous applicant (ANNEX III),** in a PDF file, named as affirmative action self-report, as specified in item 2.2 of this Notice.
- d) digital copy saved as a PDF file format/extension of their Undergraduate Diploma and/or Certificate of Completion of Undergraduate Studies. Applicants who will have earned their undergraduate degree by the end of 2024 must submit application applicant's proof of such condition, i.e., a digital copy of a document that proves that they will be able to complete their degree prior to the start of the program (March 1, 2025). If admitted to the program, applicants must submit their Undergraduate Diploma or the Certificate upon enrollment. **The copy of the diploma or certificate does not need to be certified.**
- e) digital copy saved as a PDF file of the full academic transcript of the undergraduate degree, containing information on failed courses and academic leaves. **The copy of the transcript does not need to be certified.**
- f) copy of the Curriculum Vitae Lattes/CNPq model (<a href="http://lattes.cnpq.br">http://lattes.cnpq.br</a>) saved as a PDF file. The curriculum will not be accepted in any model other than that of the Lattes Platform, except in the case of foreign applicants, who may replace the Curriculum Lattes with a copy of their Curriculum Vitae.
- g) digital copies of supporting documents for the curriculum vitae, saved together as a single PDF file, named proof of CV applicant's name, numbered and in the sequence shown in Table 1 below. Only a single file containing all supporting documents will be accepted for the purpose of curriculum vitae evaluation; activities lacking proof will not be scored. The supporting documents do not need to be certified.

- 4. Article published in conference proceedings (number of pages equal to or greater than 6 pages)
- 5. Publication of book, book chapter, or booklet with an ISBN.
- 6. Attendance to conferences and other research, teaching or university outreach events.
- 7. Simple abstract (up to one page) published in proceedings of research, teaching or university outreach events or poster/panel presentation in research, teaching or university outreach events.
- 8. Expanded abstract (two to six pages) published in proceedings of academic (teaching or university outreach) events.
- 9. Complementary training course in the areas of Agricultural and Interdisciplinary Sciences, equal to or greater than 15 class hours.
- 10. Member of the organizing committee of technical and/or scientific events.
- 11. Teaching experience in preschool, elementary, secondary and higher education
- 12. Professional experience in the field of Agroecology and Rural Development: lectures given (equal to or more than 50 minutes), courses taught (equal to or more than 15 class hours) and consulting services.
- h) Research Project in PDF file format/extension, named 'project applicant's name', on a theme related to one of the Lines of Research of PPGADR-Ar, indicated in item 2, covering the topics: Cover page containing the applicant's name, Project title and line of research; Abstract; Introduction and Justification; Objectives, Material and Methods, Execution Timetable and References. The Project cannot contain the applicant's name in the body of the text. **Applicant identification shall only occur on the cover page, which will be separated from the others when applications are accepted.** The Project must have the following presentation format: paper size: A4; line spacing: 1.5; margins: 2.5 cm; font: Arial; font size: 11; total no. of pages: maximum 10.
- i) copies of ID Card ('RG') and Individual Taxpayer Identification Card ('CPF') saved to PDF format; certified copies are not required. **Digital copies of the applicant's driver's license and employment record book will not be accepted.** Foreign applicants may send a scanned copy of their passport or identification document from their country of origin.
- 5.2. Only applications that meet all the requirements and contain all the requested documents will be accepted. Complementary documents will not be accepted after the end of the application deadline.
- 5.3. Applications can be made from 12:01 a.m. (one minute after midnight) on August 27, 2024 to 11:59 p.m. (one minute to midnight) on October 01, 2024 Brasilia (Federal District) standard time, Brazil, exclusively by email, by submitting all documents contained in item 5.1 to: ppgadrprocessoseletivo@ufscar.br. The subject line of the e-mail message must contain Application to PPGADR Applicant's full name. In the body of the message, the applicant must mention the desired line of research at PPGADR-Ar.

#### 6. SELECTION OF APPLICANTS

The Selection Process will be carried out in **two phases**:

**Phase 1:** Research Project Evaluation (eliminatory)

**Phase 2:** Defense of the Research Project (eliminatory)

Phase 3: Curriculum Evaluation (ranking round).

#### **6.1. Phase 1: Research Project Evaluation (eliminatory and ranking round)**

The Selection Process Committee will be responsible for evaluating the Research Projects, assigning grades from 0 to 10 (zero to ten). Applicants given a grade lower than 6.0 (six) in the Research Project will be disqualified. The criteria to be used in evaluating the Research Project, with a sum of 10 points, are described below:

- 6.1.4. The research project has the sole objective of evaluating applicants in this Selection Process. In case the applicant is successful in this phase, the project may be modified during the first academic semester, according to the supervisor's recommendations.

#### 6.2. Phase 2: Defense of the Research Project (eliminatory and ranking round)

Candidates who obtain a score of 6.0 or more in Phase 1 will be classified for Phase 2. It will be up to the Selection Process Committee to schedule the argument sessions, which will take place via Google Meet, according to the dates and times to be made available as described in the schedule (Annex VI). The use of Google Meet and access to the internet on the day and time scheduled for the defense of the research project is the responsibility of the candidate. The criteria for evaluating the Research Project Defense are as follows:

The supporting documentation will be considered, according to **Table 1 – 5.1.f**, **relative to the last five years (2020-2024), except for the case of item 1 of Table 1 – 5.1.f**, which will consider any year of graduation of the applicants. Activities without supporting documentation will not be scored, as stated in item 5.1.f of this notice. This evaluation will be made for classification purposes. The evaluation of the Lattes/CNPq curriculum (or Curriculum Vitae, for foreign applicants) will follow the following score:

6.4. The final score of each applicant will be determined as follows: Final score = (score from Phase 1) x 0.35 + (score from Phase 2) x 0.35 + (score form Phase 3) x 0.30

6.5. The final score of the applicant entitled to a bonus point (Affirmative Action Policy) will be determined as follows:

Final score = [(score from Phase 1)  $\times$  0.35 + (score from Phase 2)  $\times$  0.35 + (score form Phase 3)  $\times$  0,30] + 0.5

- 6.8. A waiting list with successful applicants who have not been short-listed will be disclosed for each Line of Research, considering the number of places for each Line of Research.
- 6.9. In the event of a tie in the final score of applicants within the same Line of Research, the tie will be decided by the Selection Process Committee, based on the Research Project score. If the tie persists, the Curriculum Vitae score will be used; in case the tie persists, the tiebreaker will be the applicant's age: the oldest applicant will be the top-ranking one.

- 7.3. In the challenging request, which may be rejected, the applicant shall clearly point out to whom it is directed, as well as the reasons underlying it, as well as explaining the relationships or bonds between the member of the Selection Committee and a particular applicant that has joined the selection process, a fact that may interfere with the result of the evaluation of the selection process. The items described in Annex IV are considered to be types of bonds.
- 7.4. If no challenging requested is submitted within the established deadline, the applicant will lose the right to do so.
